# Public Notice PPG Social Work no. 02/2020 Financial University Grants in Brazil linked to PPGSS/UFPE - PrInt/UFPE Research Projects

This is a public announcement of the Graduate Program in Social Work (PPGSS) of the Federal University of Pernambuco (UFPE) for applications and initial selection of grant recipients in Brazil with links to research projects for the year 2020, for activities financed by the Institutional Project for Internationalization (PII) of this university (UFPE), within the scope of activities financed by the Institutional Program of Internationalization (PRINT) and the Coordination for the Improvement of Higher Education Personnel (CAPES), according to the regulations published in Public Notice no. 41/2017 of Capes.

## 1. OBJECTIVES

- 1.1. The selection of beneficiaries of scholarships in the country of the Institutional Project for Internationalization (PII) of UFPE linked to a research project of the Graduate Program in Social Work in 2020, aims to:
- 1.1.1 Encourage the implementation and consolidation of internationalization processes in the PPGSS, with the contribution of young researchers with training abroad, through research and teaching activities;
- 1.1.2 Stimulate the formation of international research networks to improve the quality of academic production linked to postgraduate studies, based on the previous experience abroad of the proponents;
- 1.1.3 Expanding the space in the PPGSS for internationalization experiences with the involvement of teachers and students;
- 1.1.6 Integrate with UFPE's promotion actions to the internationalization effort.

#### 2. THEMES AND VACANCIES

- 2.1. Theme: Development and inequalities in the Global South: Suppression of rights and the sociopolitical implications for the life and work of peripheral populations. The sub-themes are:
  - Democracy, inequality and the denial of rights.
  - Human rights and inequality.
  - Peripheral capitalista development. Social, political and environmental impact and conflicts.
  - Labor and migration.
  - Social strugles, women's movements and confronting inequality.
  - Housing and migration. The quality of life of populations.

#### 3. REQUIREMENTS

3.1 The applications must obey the norms of Capes publication nº. 41/2017, in accordance with the requirements and procedures established by the regulations of Capes, in addition to the following requirements. The applicant will:

- 3.1.1 Make the application through the Coordinator of the Graduate Program in the Institutional Internationalization Project of UFPE within PrInt / Capes;
- 3.1.2 Be a professor or researcher with recognized competence in his or her special area;
- 3.1.3. Be the holder of a doctorate degree;
- 3.1.4 Have scientific production in the area of the Graduate Program where the grant activity will take place;
- 3.1.5 Be a resident researcher in one of the countries with which the PPGSS has interchange relations: Espanha, Itália, Portugal, África do Sul, México.
- 3.1.6 Submit a signed statement stating that the applicant is committed to the work plan and its respective schedule of activities.

#### **5. IN-COUNTRY GRANTS**

- 5.1 Young Talent with Experience Abroad: for talented young Brazilian or foreign researchers, residing abroad with proven international academic-scientific experience (such as master's or doctorate degrees, or master's or doctorate sandwich for at least twelve months) for the accomplishment of research activities and teaching.
- 5.2 In teaching activities carried out by any of the scholarship holders in the country, in the modality described above, a recording should be made for online transmission and subsequent availability, whenever possible.

#### **6. SUBMISSION OF PROPOSALS**

- 6.1 Proposals should be sent on line by the candidates to the coordinator of the Post-Graduation in Social Work containing the following: Work plan; time schedule of activities; statement signed by the applicant affirming the agreement to carry out the Work Plan within the stated timeline; and a summarized curriculum.
- 6.2. The Work Plan should have a maximum of fifteen thousand characters, with a schedule of the activity plan, including any specific experimental or laboratory infrastructure involved. It must contain the following items:
- a) Title;
- b) Introduction and justification, presenting current information that is relevant to the theme;
- c) Objectives, defining and limiting the object of study;

- d) Timeline with schedule of activities;
- e) Contribution of the work plan to the promotion of teaching, training and learning, where applicable;
- f) Potential for an expansion of the research and education network, with new techniques and partnerships, and wide dissemination of the results, as applicable;
- g) Relevance for the scientific and technological development of the area of study in Brazil, both in the medium and long term;
- h) Provision for and compliance with national and international standards, where relevant.

#### 7. SELECTION CRITERIA

- 7.1. Candidates will be selected by the PRINT/PPGSS coordination staff according to the following criteria:
- 7.1.1 Adherence to the theme;
- 7.1.2 Impact on improvement of development of research and internationalization of PPGSS;
- 7.1.3 Feasibility of executing the work schedule, in view of the length of stay and the PPG infrastructure
- 7.2 The analysis of merit will be preceded by a technical analysis of the adequacy of the proposals to the terms of this Notice, to the rules of Edital Capes nº. 41/2017, as well as the procedures established by Capes in its normative instruments (Portaria Capes nº 186, of September 29, 2017; nº 201 and nº220, of October 16, 2017; nº 08, of January 12, 2018, and other relevant instruments).

#### 8. RESULTS AND IMPLEMENTATION OF THE GRANT

8.1 The results will be published in the page of PPGSS (www.ufpe.br/pssocial), observing the schedule set forth in item 4;

### 9. ADMINISTRATIVE APPEAL

9.1 The deadline for appeal will be up to 02 (two) business days from the date of publication of the result, not giving rise to any suspensive effect, and should be forwarded to the PPGSS Coordination.

#### 10. IMPLEMENTATION OF THE GRANT

10.1 The procedures for implementing the scholarship with Capes will be carried out at SCBA / CAPES until November 18, 2020, the maximum term accepted by CAPES, for the beginning of the scholarship between the months of January and March 2021.

# 11. FINAL PROVISIONS

- 11.1 At least 70% of the PII resources at UFPE must be allocated to partnerships with institutions in countries with which Capes maintains effective cooperation.
- 11.2 Any omissions will be resolved by the PPGSS.
